The Community Equity Incubator is a two-year community capacity building and grantmaking program that aims to increase resident leadership, spark creative problem-solving, and accelerate the growth of innovative, community-based organizations.

"Positive change happens when inspired people come together to solve problems, identify solutions, and build coalitions that drive action," said Chinedum Nnodum, the Community Foundation's Director of Community Strategies. "The Community Equity Incubator seeds promising ideas for equity and social change in our community by investing directly in the people and organizations that are championing these ideas."

Point 32 Health Foundation is playing an important role in kickstarting this promising new program — committing \$100,000 over the next two years.



# **Exploring the 'Upside of Equity' in Fairfield County**

A more equitable community can benefit everyone who lives in our region.

#### THE COMMUNITY FOUNDATION IS TESTING THIS IDEA

through a year-long study that will measure the impact of racial equity on Fairfield County's economy.

The expansive first-of-its-kind study, called *The Upside* of Equity: Exploring the Economic Benefits of Closing Racial Equity Gaps in Fairfield County, is being conducted in collaboration with DataHaven and the Urban Institute. Researchers are also working closely with an advisory panel of Fairfield County community members.

The research — funded by a \$462,000 grant from the federal Administration for Children and Families — will study the costs of inequity, the benefits of equity, and how system-level solutions can lead to economic benefits for all Fairfield County residents.

"There's a common saying that 'a rising tide lifts all boats," said Dr. Tanya A. Hills, the Community Foundation's Director of Learning & Evaluation. "This research aims to test that idea in ways that identify and quantify the impact of equitable policies and practices on the broader community."

In turn, the Community Foundation aims to provide an economic case for creating an equitable Fairfield County.

"Efforts to increase fairness, opportunity and access in our region should be rooted in ethics and justice," said Mendi Blue Paca, FCCF's President and CEO. "But not everyone is guided by moral arguments. For many, economic data is a persuasive point for looking at challenges in new ways and with different goals. We anticipate that *The Upside of Equity* will provide some of that perspective."



## "It's Pure Gratitude Driving Us"

**WHEN TOM SANTA'S FATHER** and uncles sought ways to mark the 50th anniversary of Santa Energy, there was plenty to celebrate. After all, their parents Stephen and Madelyn had started the family business in 1940 with a single truck. They eventually expanded to provide fuel services for 27 towns in Fairfield and New Haven counties.

While the brothers were eager to mark their parents' business success, they wanted to show appreciation to their customers, too.

In 1990, they did both—by creating the Stephen and Madelyn Santa Environmental Fund at the Community Foundation. With company contributions to this corporate donor-advised fund (DAF), Santa Energy made grants to nonprofits serving local residents—and they haven't stopped.

According to Tom, part of the third generation of Santas to lead the company, the fund also reflected their business values. "Santa Energy was always tuned into energy conservation and environmental protection," he stated. "In an industry like ours, it's a focus."

In 2016, compelled by the company's continued good fortune, the family established another corporate DAF, the Santa Family Fund, at the Community Foundation. "Santa Energy wanted to do even more for the community," he said. "It's pure gratitude driving us."

With its company headquarters in Black Rock Harbor and deep family roots in Bridgeport, most grants from the fund are directed to improving educational opportunities for city residents.

"Tradesmen support our industry, so trade education is a particular focus," Tom noted. "We hope the Community Foundation continues to tell us where help is needed so we can broaden our vision and find new opportunities to make a difference."

# For the Weismans, Community is Family

IN THE EARLY YEARS OF THEIR MARRIAGE, Joan Weisman and her late husband Fred relocated frequently around the country. From Kansas City to Phoenix to Las Vegas to Stamford they met neighbors who expanded their perspectives about the challenges communities face. For the Weismans, their communities became their extended family—and an inspiration for social action.

The upbeat duo rolled up their sleeves wherever they settled, organizing dinners for people experiencing homelessness, serving on nonprofit boards, and supporting families during the holidays.

"My husband had incredible energy," Joan says fondly.

"And it was an important example to set for our children."

To achieve the same level of impact through philanthropy as they did through volunteering, Joan and Fred connected with Fairfield County's Community Foundation 30 years ago and opened the Fred and Joan Weisman Fund, a donor advised fund. Joan also became a founding donor of the Community Foundation's Fund for Women & Girls.

"Over the years, we got valuable advice on investing in charities," Joan says. "We relied on the Community Foundation's thorough research so we could give wisely, get exposed to different nonprofits, and learn about our community's needs. We found the right places to donate and felt good about it. Because what's this world like if you can't help other people?"

Since Fred's passing, Joan has continued their legacy of caring. A decade since starting the first social action committee at her Stamford retirement community, she's raised astonishing sums for Alzheimer's research and cancer treatment through playful fashion shows and lively silent auctions and adult carnivals. "Fundraising is fun!" Joan proclaims.
