The Community Foundation supports each donor's vision of community, whether it's local, national, or global. ## Your Planned Giving Options

Whatever your stage of life, we're here to help you create a plan that meets your philanthropic vision and financial goals. Your gifts—from wills to trusts, and other assets—can support specific charities or enable the Community Foundation to meet the region's most pressing needs. No matter your age or your income, you have options to give a forever gift to your community.



#### **Bequest**

The simplest and most common way to make a legacy gift is through a bequest in your will. By naming the Community Foundation as a beneficiary, you gift us your assets (cash, stocks, appreciated securities, or personal property) after your lifetime—in any amount or as a percentage of your estate. You can direct your gift to a specific fund or field of interest at the Community Foundation or entrust us with an unrestricted gift so we may flexibly focus the dollars on the most pressing community needs.

#### **Real Estate**

Donating real estate is an impactful way to advance our mission and provide a lasting legacy. Giving real estate as a charitable contribution can unlock several tax, income, and estate planning benefits while driving meaningful impact. We can tailor a giving solution that fits your needs and accept almost any kind of real estate in the US.





#### Life Insurance

When the original purpose for a life insurance policy no longer applies—such as educating children or providing financial security for a spouse—your policy can become a meaningful way to support your community. You can name the Community Foundation as a beneficiary of the policy (using a percentage or specific dollar amount) or make an outright gift of an existing policy.





#### **Charitable Lead Trust**

You transfer cash, securities or other assets into a trust that makes payouts to the Community Foundation for a fixed number of years—while you receive tax benefits. At the end of the trust term, your beneficiaries (such as family members or specific charities you designate) receive the remainder of the trust with substantial tax savings.



#### Charitable Remainder Trust

You can give assets that "remain" after your heirs are cared for through a charitable remainder trust. It works like this: You and/or others you designate receive annual income for life or for a fixed term, while you receive the tax benefits. Then, at the end of the income period, the trust's remaining assets pass to the Community Foundation.

#### **Retirement Assets**

When retirement assets pass to your heirs, they can be subject to estate and income taxes. As a result, many donors choose to fund their charitable giving by designating the Community Foundation as the beneficiary of their retirement accounts. You can do this simply by completing a beneficiary designation form provided by the company that administers the account. If you are 70½ years of age or older, you can also consider a tax-free distribution from your Individual Retirement Account (IRA) directly to the Community Foundation.

## A Loving Legacy in Bridgeport

Bruce Hubler was perched atop a Bridgeport beach lifeguard stand the moment his 58-year love affair began with his future wife, Michele. Soon, they also shared an enduring love for the city.

#### **BRUCE WAS THE THIRD GENERATION IN HIS FAMILY**

**TO LIVE IN THE CITY,** and Michele had moved there as a teen. After they married, they bought a home in Bridgeport's Black Rock neighborhood and never left, despite Bruce's business successes tugging him toward New York City.

"We couldn't get ourselves to step out of Bridgeport," Bruce reflected. "We loved it there."

The Hublers' interest and involvement in the city's neighborhoods and people enriched their lives in countless ways. Bruce served on five nonprofit boards, including the Community Foundation's, and Michele devoted her energies to many local charities.

Before Michele passed away in 2021, the Hublers discussed creating a 'legacy gift' through the Community Foundation. They were keenly aware of the educational disparities facing Bridgeport's young people compared to suburban peers, and the couple viewed philanthropy as a way to break down barriers keeping youth from equal opportunities to do well.

Through a bequest in his will, Bruce set up the Bruce and Michele Hubler Fund, which will solely benefit Bridgeport residents after his lifetime. The Community Foundation will award grants from the fund to support children's summer enrichment activities as well as the health and welfare of preschool children and older adults with lower incomes.

that open educational doors for Fairfield County's young people, and on the tax strategies most effective for him to do it.

Bill created the Knobloch Fund at the Community Foundation in 2001. Since then, he's been lowering his

tax rate and building the fund through gifts in the form of appreciated stock. And he's entirely hands-on in selecting the nonprofits his donor-advised fund supports.

"Growing up and living in Stamford for so many years gave me real knowledge of what the community needs and the organizations seeking the funding to meet those needs," Bill said.

He relies on his own research and the Community Foundation's deep local expertise to make grant decisions. And he's jumped at the chance to accompany the Community Foundation's philanthropy staff on tours of youth programs. ("You should go visit, too!" he'd tell you approvingly.)

In Bill's view, mentoring and afterschool programs through nonprofits like Project Music, Starfish Connection, Future 5, and the Stamford Museum and Nature Center could make all the difference for a young person striving to graduate from high school to make a better life.

That's why Bill worked with an estate attorney to create a charitable remainder trust. After his lifetime, the funds will provide enduring support for local youth on their paths to meaningful careers and self-sufficiency.

"Education," he says, "is tremendously important in life."
